AND UPON THE COURT considering that the time that has elapsed since the vacation from office by the Applicants as administrators of the Company required an order to be made forthwith with a judgment setting out the written reasons for the order to be handed down subsequently

IT IS ORDERED AND DIRECTED that:

1. The Applicants' discharge from liability pursuant to paragraph 98(1), Schedule B1, Insolvency Act 1986 shall take effect 28 days from the date on which this Order is published on the Company administration website at https://petropavlovskplc.com/insolvency-news/.
